## 25-103 RAF Liaison Officers Report

Sqn Ldr Hicks sent the following report:

In terms of Programme MARSHALL and the decommissioning of our radar still no end date in sight. A workshop at RAF Leeming is planned for Aug to strip back their new radar, then to rebuild it and the software and they hope but it's not certain that this may resolve the issues they are experiencing at this time. So it's still wait out on our part.

Reinstatement works at the main gate completed and now awaiting a decision from Annington Homes as to when they plan to release the housing for rent/lease. We believe late Summer and therefore at that point the Main Gate will become permanently open for the residents whilst we retreat behind our Green 'delineation' fence with Rayan continuing to provide a Guard Service with 24/7 CCTV.

Regards security we've had, since the last meeting and thankfully this is very rare, one incident of a family walking on the airfield at a weekend which incurred additional costs in a patrol being deployed to ensure gates / facilities etc remained secure, which they all were. Although we have a CCTV photograph of the family my sources have been unable to identify the family but I would ask the Parish Council to gently remind residents that the site is still a Defence establishment, therefore out of bounds, until sold or
